If we name a pupil in the text, we will not use a photograph of that child to accompany the article. If a child has won an award and the parent would like the name of their child to accompany their picture we will obtain permission from the parent before using the image.

From time to time, our school may be visited by the media who will take photographs or film footage of a high profile event. Children may appear in these images, which will sometimes be published in local or national newspapers.

Conditions of use

We will not re-use any photographs or recordings a year after your child leaves this school, however historic photographs may remain on our school website and social media feeds.

We will not use the personal details or full names (which means first name and surname) of any child or adult in a photographic image or video, on our website, on our social media platforms in our school prospectus or in any of our other printed publications.

If we use photographs of individual pupils, we will not use the name of that child in the accompanying text or photo caption.

If we name a pupil in the text, we will not use an individual photograph of that child to accompany the article.

We may include pictures of pupils and teachers that have been drawn by the pupils.

We will only use images of pupils who are suitably dressed, to reduce the risk of such images being used inappropriately.

Internet Use

How the Internet will be used by Year Group

Reception	Only access web based programs approved by the teacher.
Year 1 & 2	Access web based programs approved by the teacher. Open a link provided by the teacher to access and navigate learning website.
Year 3, 4, 5 and 6	Access web based programs approved by the teacher. Input and open web addresses approved by the teacher. Use school email to send and receive messages to/from people approved by the teacher Use web search engines to find and open websites linked to learning.

Rules for Responsible Internet Use in School.

The school has installed computers and devices with Internet access to help our learning. These rules will help keep us safe and help us to be fair to others.



Using the computers:

I will only access the computer system with the login and password I have been given.

I will not access other people's files.

I will not bring in memory sticks or devices from outside school and try to use them on the school premises.

Using the Internet

I will ask permission from a teacher before using the Internet.

I will report any unpleasant material to my teacher immediately because this will help protect other pupils and myself.

I understand that the school monitor, filter and check my computer files and Internet sites I visit.

I will not complete and send forms without permission from my teacher.

I will not give my full name, my home address or telephone number when completing forms.

Using E-Mail

I will ask permission from a teacher before checking the e-mail.

I will immediately report any unpleasant messages sent to me because this would help protect other pupils and myself.

I understand that e-mail messages I receive or send may be read by others.

The messages I send will be polite and responsible.

I will only e-mail people I know, or my teacher has approved.

I will only send an e-mail when it has been checked by a teacher.

I will not give my full name, my home address or telephone number.

I will not use e-mail to arrange to meet someone outside school hours.
